

Summary Annual Report

For Convatec, Inc. Savings and Investment Plan

This is a summary of the annual report for Convatec, Inc. Savings and Investment Plan, Employer Identification Number 26-2734330, Plan No. 001 for the period January 01, 2019 through December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$22,577,391. These expenses included \$24,363 in administrative expenses and \$22,552,336 in benefits paid to participants and beneficiaries and \$692 in other expenses. A total of 2025 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$155,634,857, as of December 31, 2019 compared to \$132,894,388 as of January 01, 2019. During the plan year, the plan experienced an increase in its net assets of \$22,740,469. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$45,317,860, including employer contributions of \$4,551,029, employee contributions of \$8,266,535, other contributions of \$1,377,781, realized gains of \$6,485 from the sale of assets, and earnings from investments of \$31,116,030.
